Abstracs

Language Education and Teaching Approaches in Pakistan

Assoc. Prof., Dr. Nadia Anwar Dean, School of Liberal Arts University of Management and Technology Lahore, Pakistan



Dr. Nadia Anwar is an Associate Professor in the Department of English and Literary Studies and Dean of the School of Liberal Arts at University of Management and Technology, Lahore. ICT self-efficacy, defined as an individual's belief in their ability to successfully use digital tools and technologies, not only enhances digital competence but also fosters autonomous and self-directed learning. This talk examines the intricate relationship between ICT self-efficacy and SRL, emphasizing how learners' confidence in their technological skills can improve their ability to set goals, manage their learning processes, and reflect on their progress. Furthermore, it discusses practical strategies to foster SRL in EFL classrooms, highlighting the importance of integrating digital tools and encouraging learner autonomy. By equipping students with the skills and confidence needed to navigate digital environments, educators can promote more effective and independent learning experiences. This talk also addresses future directions in English Language Teaching (ELT), suggesting innovative approaches to blend technology and pedagogy for enhanced language acquisition. Additionally, multimedia content videos, podcasts, and e-books enriches the learning experience by offering real-world contexts and authentic language exposure. These tools also support self-paced learning, allowing learners to progress at their own speed, reducing the impact of teacher shortages. Ultimately, technology tools are helping Nigeria enhance language acquisition and promote linguistic diversity in a rapidly evolving educational landscape.

The Effect of Modality in Foreign Language Learning: Experiments on the Recall of New Concepts Presented Through Images, Text, and Image + Text

Prof. Dr. Hamit Coskun Psychology Department Bolu Abant Izzet Baysal University Bolu, Turkiye



Prof. Dr. Hamit Coşkun graduated from Hacettepe University, Faculty of Letters, Department of Psychology in 1991. He completed his master's degree in 1996 at The University of Texas at Arlington (UTA) in the USA and his doctorate in 2000. Hamit Coşkun, who started his academic life in 1993 as a Research Assistant at Abant İzzet Baysal University, Department of Psychology, received his Associate Professor title in 2006 and started working as a full-time Professor in 2011. He was the Founding Department Head in 2001-2009, Department Head between 2011-2020, acted as the Dean of the Faculty of Arts and Sciences in 2014-2018, and was appointed as BAIBU Vice President in 2016. In 2006, he received the "Outstanding

Young Scientist Award" from the Turkish Academy of Sciences. Some of his research interests are "Brainstorming", "Creativity", "Cognitive Arousal", "Team/Teamwork", "Mood/Affective Behaviors", "Psychosocial Behaviors" and "Behavioral/Affective/Epigenetic Processes".

Abstract

This study examines the effects of images and text comparatively and the combination of images + text on cognitive processing and recall in the German and Turkish languages. The research is based on Paivio's Dual Coding Theory, which suggests that verbal and visual encoding information can enhance recall. Participants were randomly assigned to one of three groups: (1) Image only, (2) Text only (in German or Turkish), and (3) Image + Text. During the experimental procedure, stimuli were presented for a set duration, followed by free recall and recognition tests. Participants in the image + text condition demonstrated significantly superior performance. The findings may contribute to understanding the interaction dynamics of visual and verbal information in multilingual individuals and offer applicable insights for fields such as education, memory research, and the design of visualized learning materials.

Two British-Iraqi Playwrights Re-present the US Occupation of Iraq

Dr. Salih Mahdi Hameed, Professor, is a scholar in English literature, but his major field is dramatic literature. He has been a visiting scholar in the Department of Drama at Ohio State University, Columbus for the years 2004 and 2007. Nevertheless, he was also a visiting the Department of Theatre, Southampton University, UK, for the years 2009 and 2012. Since his early retirement in 2013, he has been devoting efforts to translate dozens of English language US\Iraq War plays into Arabic besides his main research activities.

Abstract

The East-West duality in European culture is indeed old-aged. Much before Kipling's Ballad "Oh, East is East, and never the twain shall meet / Till Earth and Sky stand at God's great Judgement seat," the Western allegations against the East have been a subject of countless authors since even the Middle Ages. George Bush's statement that his war on Iraq is a new "Crusade" illustrates how deep-rooted the animus is in the Western conscience. Bush's use of the term 'crusade' could never be a "slip of the "tongue", and it is quite ridiculous to think like that: ironically enough, it is identical to his lies of the Iraqi Mass Destruction Weapons. The American media, culture and some arts cannot be an exception to other former abundant writers. The Western audience/readers normally sympathize with these misrepresentations and defamations due to the very fact that the images of the East has been ingrained in people's minds and ceaselessly permeated in their collective memories for ages. Interestingly enough, two British-Iraqi playwrights who have fully experienced both the Eastern and the Western cultures equally well, have nevertheless, similarly suffered the consequences of the Western 'squint' and prejudiced "Otherness". The playwrights admit to have undergone such experiences. Hassan Abdulrazzak and Dina Mousawi who are both British playwrights of Iraqi origins have written Baghdad Wedding and Return respectively. The plays were well received by the European audience where that were performed. Both plays have nevertheless been written after the playwrights had made visits to their native country after the US invasion in 2003. In his Foreword to Baghdad Wedding emailed to the research worker Abdulrazzak writes: "Part of my enthusiasm]to write the play[stemmed From the fact that I wanted to give a different image of Iraqis from the one portrayed by the British media Britain has always enjoyed feeling superior to other nations particularly that they colonize". Referring to David Hare's Stuff Happens, Abdulrazzak believes that the "problem wasn't just the media but in the theatre also." On the other hand, Dina Mousawi, who is also a British actress, uncovers similar opinions when she "was ignored for any role for Iraqi women in The Devil's Double, but, Ironically asked to do some (Automated Dialogue Replacements) for the same film." She says that she was astonished to see a "white actress, hair dyed black playing what should have been one Iraqi woman. Countless other small female characters popped up, none of whom were played by Arab women." She, therefore, concludes that she felt Iraq was "annihilated by Western forces and then misrepresented,"

a matter that compelled her (as well as Abdulrazzak above) to make honest works about Iraq and its people. This paper, however, is a study of how these British-Iraqi playwrights honestly re-present the Iraqis far beyond the Western Squint prejudiced "Otherness" theory of the West.

Hospital Management Information System (HMIS): An Agent To Anti-Deforestation And Anti-Pollution Virtual Healthcare Communication In Pakistan

Abstract

Pakistan is a South Asian country with a population of more than 240 million. Over the years, rapidly increasing population has triggered urbanization at the sake of deforestation for construction of large scale residential and commercial buildings. This massive deforestation has resulted into environmental decline. During the last decade, Lahore, a major city of Pakistan has been ranked the top polluted city of the world for high air quality index (AQI) and dense smog. In the tech-savvy world, Hospital Management Information System (HMIS) has emerged as virtual healthcare communication replacing traditional written medium of diagnostics and prognostics. This online digital communication transmits patients' case history, prescriptions, clinical reports, and pharmacy operations in a paperless environment, the hallmark of eco-friendly virtual healthcare communication. The purpose of this quantitative study is to align with Sustainable Development Goal – 13 (Climate Action) to prevent deforestation for eco-friendly Pakistan. Web content audit/ analysis (Jankovic, 2020) has been used to analyze HMIS as an agent to anti-deforestation and antipollution virtual healthcare communication. Virtual face sampling technique (Meyer, 2008a & 2008b) has been employed to sample a Lahore based 600 bedded tertiary hospital affiliated with a private sector Medical and Dental College having HMIS facility. Data spanned over one year (January 1, 2024 – January 1, 2025) were collected from all OPDs, IPDs, Radiology, Laboratory,

and other allied departments of the hospital. The study finds that by switching over to HMIS, hospital has saved 1,117,864 papers per annum as compared to traditional written diagnostics and prognostics. HMIS avoided deforestation of 112 trees per annum as one tree produces 10,000 papers. HMIS is adding green effect to the environment as anti-deforestation and anti-pollution agent through eco-friendly healthcare communication. Acheson & McCloskey (2008) also found that the deforestation for the paper production is the major reason for deteriorating environment in Maine locality of USA. The study recommends Pakistan government to formulate policy guidelines for installation of HIMS in hospitals to prevent deforestation, smoggy, and polluted environment. Management of housing and commercial projects should plant new trees to maintain healthy air quality index (AQI).

While AI can be a valuable support, I argue that pedagogical needs require pedagogical solutions, and technology alone cannot address them. Therefore, pedagogy should guide and precede technology in instructional planning.

Abstract

Sports discourse has been highly intertwined in portraying nationalism, patriotism, and national ideologies. The objectives of the study are to identify the ideological overtones in the multisemiotic portrayal of Arshad Nadeem. Researchers have collected data from three Pakistani English newspapers' reports, which were published right after his success in javelin throw in Olympics 2024. To explore identity construction and ideologies through victory in sports, Kress and Leeuwen (2021)'s visual grammar was employed. For the analysis of news reporting, UAM software is used to see the transitivity processes as proposed by Halliday (1985). The findings reveal that Arshad Nadeem has been portrayed as a symbol of strength and vigor by highlighting his throwing postures as a national hero, with a strong sense of patriotism, a devout Muslim and a proud Pakistani. Qualitative analysis identifies the dominance of the material process that signifies the presence of tangible realities. The integrated analysis reveals emphasis on Arshad Nadeem's achievements, which portrays him as a transformative agent of national pride, who has strengthened the ideologies of nationalism, faith and perseverance and emerged as a strong competitor to India. The findings of the study have implications for recognizing media narratives of sports as a source of constructing national identity and pride that may have a healthy impact globally. This research contributes to the field of multimodal analysis by presenting it as an appropriate analysis of athletic semiosis.

Abstract

The advancing technology provides English as a Foreign Language (EFL) educators with many opportunities to utilize digital resources in their teaching practices. In this sense, besides its contribution to digital literacy skills, Digital Storytelling (DST) becomes prominent with its other multiliteracy features such as multimodality enabling the use of visual, auditory and textual forms together. On the other hand, DST with its project-based nature allows EFL students to take active roles in their own learning processes by ensuring the use of all language skills through various apps. Furthermore, it is crucial to create authentic contexts during DST practices to boost motivation. As an ongoing MA Thesis, this action research aims to reveal EFL students' perceptions towards learning English by providing the required authenticity thanks to the DST tasks integrated with local cultural assets. The study, which is being conducted by a teacher researcher, includes an eight-hour DST program where a private high school's students have to present a cultural asset related to the city they live in Türkiye by means of multimodal elements. Upon completing their presentations, purposively selected 20 students are asked to participate in a survey and answer evaluative questions to define their perceptions about gaining English Language skills. The qualitatively analyzed results obtained from Google Forms service are indicated as percentages to shed light on new studies in the field of EFL.


